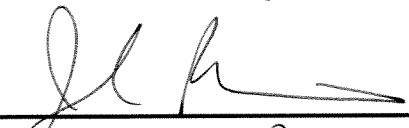

WHEREAS, ASSIGNOR is desirous of granting to ASSIGNEE its ownership of the aforesaid Patent Assets.

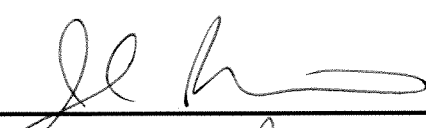
