Assignor also hereby sells and assigns to Assignee, its successors and assigns, all foreign rights to the invention disclosed in said application, in all patent-granting countries of the world, including the right to file applications and obtain patents for said invention in its own name in said countries, including all rights of priority under the terms of the International Convention for the Protection of Industrial

Property, and further agrees to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights.

Assignor hereby further agrees to communicate to Assignee, its successors, assigns and representatives, any facts known respecting any improvements, and at the request and expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, reexamination and substitute applications, make all lawful oaths, and generally do everything possible to aid Assignee, its successors, assigns and representatives to obtain and enforce proper patent protection for said invention in all countries.


Assignor hereby grants Harvey B. Jacobson, Jr.; John C. Holman and Suzin C. Anderson (Registration Nos. 20,851, 22,769 and 40,495, respectively) the power to insert on this Assignment any further identification which may be necessary or desirable in order to identify the related application, or otherwise comply with the rules of the United States Patent and Trademark Office, for recordation of this document.
