199 Bay Street, Suite 2200, Toronto, Ontario M5L 1G4, to amend the present assignment document at any time, including following execution, by inserting or correcting the title, country of filing, serial number, filing date, or any other identifying information of the Application, as may be necessary or required in order to have the present assignment document recorded in a patent office or other public registry or for any other lawful purpose.
