(h) any and all patents of countries foreign to the United States of America that may issue from the foreign-filed applications, refilings, divisions, and continuations; and


(i) any and all extensions of, and additions to, the patents of countries foreign to the United States of America;

(j) the right to apply or continue prosecution for any of the above and revive prosecution of any abandoned rights for any of the above; and


