ASSIGNMENT

WHEREAS, **Consejo Superior De Investigaciones Cientificas**, an entity organized under the laws of Spain and having an office and place of business at C/Serrano, n° 117, 28006 Madrid, Spain (hereinafter referred to as the "CSIC") and **Universidad de Castilla La Mancha**, an entity organized under the laws of Spain and having an office and place of business at C/. 
