WHEREAS, Assignor, Assignee and certain restricted sellers are parties to that certain Asset Purchase Agreement, dated as of November 6, 2015 (the "Agreement") and the Agreement provides for the execution and delivery of this Assignment by Assignor to Assignee;

WHEREAS, Assignor owns all worldwide right, title, and interest in and to the inventions and discoveries described in the patent applications and patents set forth on Schedule L as well as all patents and patent applications (such as divisional applications, continuation applications, continuation-in-part applications, national applications derived from regional applications) generated from any of the applications listed herein (collectively, the "Assigned Patents"); and

WHEREAS, Assignee desires to purchase or acquire all of Assignor's right, title and interest in and to the Assigned Patents;

NOW, THEREFORE, subject to the terms and conditions of the Agreement and in consideration of One Dollar (\$1.00) and other good, valuable and sufficient consideration, the receipt of which is hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

1. Assignor hereby sells, conveys, assigns and transfers to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in and to the Assigned Patents, free and clear of all Encumbrances, other than Permitted Encumbrances; including all rights to the inventions and discoveries contained therein; all rights to apply for registration in any country or jurisdiction throughout the world with full benefit of such priority as may now or hereafter be granted to it by law, treaty or other international convention; and all rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Patents, including, without limitation, the right to compromise, sue for and collect such profits and damages; all of the foregoing to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

2. From and after the Closing Date, Assignor shall, without further consideration, execute and deliver such instruments of transfer, conveyance, assignment and assumption, in addition to the Ancillary Agreements, and take such other action as may reasonably be necessary to consummate the Contemplated Transactions or to give effect to the transactions contemplated by the Ancillary Agreements.

3. Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand, supersede or limit in any way the terms, conditions or obligations

of the Agreement. To the extent any provision of this Assignment conflicts with or is inconsistent with the terms of the Agreement, the Agreement shall control and govern.

4. Capitalized terms used herein without definition shall have the meanings set forth in the Agreement.

5. This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to patent issues and in all other respects, including as to validity (except for patent validity issues), interpretation and effect, by the laws of the State of Delaware without giving effect to the conflict of laws rules thereof.

6. This Assignment may be executed electronically or otherwise (where permitted in an applicable jurisdiction) in any number of identical counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
