## PATENT ASSIGNMENT

This Patent Assignment ("Agreement") is between 89908, Inc., a California corporation ("Assignor") and Lund Motion Products, Inc., a Delaware corporation (the "Assignee" and together with the Assignor, the "Parties") and shall be on October 1, 2013 (the "Effective Date").

WHEREAS, the Parties have entered into an Asset Purchase Agreement (the "APA") effective on October 1, 2013; and

WHEREAS, the APA requires Assignors to assign certain patents to Assignee as further set forth herein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

### 1. Definitions

1.1. Capitalized terms used herein and not otherwise defined herein will have the meanings given such terms in the APA.

1.2. "Patents" shall mean patents and applications identified on Exhibit A hereto.

2. Patent Assignment. Assignor hereby sell, assign and transfer to Assignee, its successors and assigns, absolutely and forever, the entire right, title and interest in and to the Patents throughout the world and the inventions and designs covered thereby, including the right to claim priority and the right to any continuation, division, continuation-in-part, or substitute application thereof and the right to any reissue, restoration, extension or reexamination of any patent thereof, the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns and legal representatives, to the end of the term for which the Patents have been or will be granted, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made; together with all claims by Assignor for damages by reason of past and future infringement of the Patents with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.

Assignor further agrees to execute any and all documents necessary or desirable to properly vest full right, title and interest in and to the Patents throughout the world in the name of Assignee and its successors and assigns or which may be necessary to obtain, maintain, issue or enforce said Patents.

Assignor also hereby grants Assignee the power to insert on this Patent Assignment any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office and/or any applicable foreign patent office for recordation of this document.

3. Assignor Obligations. Assignor hereby accepts and ratifies all obligations related to the Patents set forth in the APA and nothing in this agreement shall limit the representations, warranties, and covenants set forth therein.
4. Assignee's Obligations. Assignee hereby assumes the obligation and agrees to prosecute and maintain the Patents.
5. Further Documentation. Each party shall execute, acknowledge, and deliver to the other party, or shall cause the execution, acknowledgement, and delivery to the other party of such further documents and instruments as either party shall deem necessary to effect the intent and purpose of this Agreement.
6. Miscellaneous

6.1. Waiver. The waiver by a party of any breach of this Agreement by the other party in a particular instance shall not operate as a waiver of subsequent breaches of the same or different kind. The failure of a party to exercise any rights under this Agreement in a particular instance shall not operate as a waiver of such party's right to exercise the same or different rights in subsequent instances.

6.2. Governing Law. This Agreement, the construction of this Agreement, all rights and obligations between the Parties to this Agreement, and any and all claims arising out of or relating to the subject matter of this Agreement, shall be governed by the laws of Delaware, without regard to its conflicts of law principles.

6.3. Entire Agreement. This Agreement contains the entire understanding of the Parties with respect to the subject matter hereof and may be amended only by a writing signed by authorized representatives of the Parties.

6.4. Headings. The headings and captions in this Agreement are for convenience purposes only, and shall not be used to construe the terms of this Agreement.




