WHEREAS, Assignor hereby agrees to and does transfer and assign to Assignee certain assets presently held by Assignor; and



Assignor hereby assigns and transfers to Assignee, its successors, assigns, and legal representatives, Assignor's entire and worldwide right, title, and interest in and to: (i) the Patent Rights owned by Assignor that are listed in Exhibit A; (ii) any and all of the inventions which are disclosed and claimed in the Patent Rights; (iii) any and all of the inventions which are disclosed but not claimed in the Patent Rights; (iv) all continuation, divisional, continuing, substitute, renewal, reissue, and all other patents and applications for patent, industrial property, or other related intellectual property rights in any and all countries which have been or shall be filed on any of the inventions disclosed in any of the Patent Rights; (v) all original and reissued patents, industrial property, or related documents, which have been or shall be issued on any inventions covered by any of the Patent Rights; and (vi) all rights to sue and recover for, and all rights to, profits and/or damages due or accrued arising out of or in connection with any and all past, present, or future infringements of any or all of the Patent Rights and any and all patents arising from the Patent Rights.

Assignor authorizes and requests that any and all patent or intellectual property offices anywhere in the world issue to Assignee, its successors, assigns, and legal representatives, in accordance with this Assignment, any and all patents, letters patents, or other intellectual property right that arise from any of the Patent Rights.



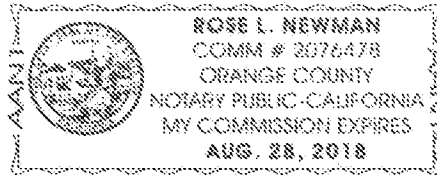
