## ASSIGNMENT



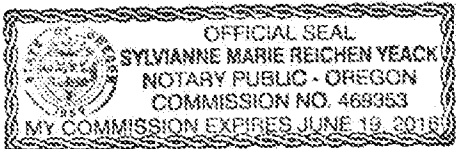


