CONFIRMATORY ASSIGNMENT OF INTELLECTUAL PROPERTY

This **CONFIRMATORY ASSIGNMENT OF INTELLECTUAL PROPERTY**, dated February 8<sup>th</sup>, 2016 (the "**Assignment**"), is made and entered into by and among **SEASONS 4, INC.**, with its principal offices at 3601 La Grange Parkway, #500, Toano, Virginia 23168 (such company together with all subsidiaries, divisions, and all other affiliates of such company, are referred to herein collectively as "**Assignor**") and **POLYGROUP LIMITED (MACAO COMMERCIAL OFFSHORE)**, a Corporation duly organized under the laws of S.A.R., People's Republic of China with its principal offices at Unit J, 10<sup>th</sup> Floor, Macau Square, Av do Infante D. Henrique, No. 43-53A, Macau (such company together with all subsidiaries, divisions, and other affiliations of such company, are referred to herein collectively as "**Assignee**");

WHEREAS, pursuant to a Concept Option Agreement, dated as of January 19, 2016, by and among Assignee and Assignor (collectively, the "**Agreement**"), Assignor assigned to Assignee all right, title and interest of Assignor in and to, among other things, the patents (along with all other intellectual property rights associated therewith) described in Schedule B of the Agreement, and which are shown in Exhibit 1 attached hereto (the "**Initial Acquired Concepts**");

WHEREAS, the parties desire to confirm the assignment so that Assignee may record the same with the United States Patent and Trademark Office and with other offices or authorities; and

NOW THEREFORE, for the good and valuable consideration and the material premises set forth in the Agreement, the prior receipt and sufficiency of which is hereby acknowledged by Assignor, Assignor hereby confirms to Assignee, its successors and assigns, the prior assignment and transfer of all of Assignor's right, title and interest in and to all of the Initial Acquired Concepts to Assignee.

Assignor expressly agrees to execute and deliver, at the request of Assignee, all other papers, instruments, and other documents and to perform any other acts Assignee may require in order to vest all right, title and interest in and to the Initial Acquired Concepts in Assignee and to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee.

This Assignment is subject to the terms of the Agreement and is not intended in any way to supersede any provision of the Agreement. In the event of any conflict between the terms of this Assignment and the terms of the Agreement, the terms of the Agreement shall control.


