## ASSIGNMENT OF PATENTS AND PATENT APPLICATION NUNC PRO TUNC

I, Victor Lee, of the city of Livingston, in the county of Essex, and the state of New Jersey, having an address at 22 Aspen Drive, Livingston, New Jersey 07039 am the sole inventor of U.S. Patent No. D510,009, issued on 09/27/2005, Title: "Knife", U.S. Patent No. 6,976,311 B2, issued on 12/20/2005, Title: "Method and Apparatus for Attaching and Detaching Two Utensil", and U.S. Patent application No. 14/088,467, filed on 11/25/2013 for Title: "Method and Apparatus for Knife" (hereinafter "the U.S. patents and U.S. patent application");

Whereas MASTER CUTLERY INC., as of 11/25/2013 was a corporation of the State of New Jersey, having an address at 700 Penhorn Avenue, Secaucus, N.J. 07094;

I, hereby agree, that for value received, I sold, assigned and transferred to MASTER CUTLERY INC., and its successors, assigns and legal representatives, the entire right, title and interest, for the United States of America, in and to certain inventions as specified in the U.S. patents and U.S. patent application nunc pro tunc effective at least as early as November 25, 2013, and all the rights and privileges in the U.S. patents and U.S. patent application and under any and all Letters Patent that may be granted in the United States for said inventions; and I also concurrently sold, assigned and transferred to MASTER CUTLERY INC., nunc pro tunc effective at least as early as November 25, 2013, the entire right, title and interest in and to said inventions for all countries foreign to the United States, including all rights of priority arising from the application aforesaid, and all the rights and privileges under any and all forms of protection, including Letters Patent, that may be granted in said countries foreign to the United States for said inventions.

I authorized, nunc pro tunc, at least as early as November 25, 2013, MASTER CUTLERY INC. to make application for such protection in its own name and maintain such protection in any and all countries foreign to the United States, and to invoke and claim for any application for patent or other form of protection for said inventions, without further authorization from me, any and all benefits, including the right of priority provided by any and all treaties, conventions, or agreements.

I consented, nunc pro tunc, at least as early as November 25, 2013, that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of MASTER CUTLERY INC., and its successors, assigns and legal representatives, to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.

I requested, nunc pro tunc, at least as early as November 25, 2013, that any and all patents for said inventions be issued to MASTER CUTLERY INC. and its successors, assigns and legal representatives in the United States and to MASTER CUTLERY INC. and its successors, assigns and legal representatives in all countries foreign to the United States, or to such nominees as MASTER CUTLERY INC. and its successors, assigns and legal representatives may designate.


