## FULL RELEASE OF SECURITY AGREEMENT


THIS FULL RELEASE OF SECURITY AGREEMENT (this "Release") is made and entered into this 11 day of February, 2016, by RABO AGRIFINANCE, INC., a Delaware corporation ("Administrative Agent"), in favor of RICETEC, INC., a Delaware corporation ("Debtor").

WHEREAS, Administrative Agent and Debtor entered into that certain Patent and Trademark Security Agreement by and between Debtor and Administrative Agent, dated as of December 20, 2011 (the "Security Agreement"), which was recorded with the United States Patent and Trademark Office on February 17, 2012, at reel and frame number 027727/0911 with respect to patents, and recorded with the United States Patent and Trademark Office on February 17, 2014, at reel and frame number 4719/0260 with respect to trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself, the Lenders (as defined in the Security Agreement), the Swing Line Lender (as defined in the Security Agreement), and the L/C Issuer (as defined in the Security Agreement), hereby: (i) terminates the Security Agreement; and (ii) unconditionally and irrevocably releases, terminates and forever discharges and extinguishes any and all of its right, title and interest in and to any and all liens and security interests in the Collateral (as defined in the Security Agreement), including with respect to Patents (as defined in the Security Agreement), including, but not limited to any of those described more fully in Schedule A attached hereto and any and all patent applications including, but not limited to any of those described more fully in Schedule B attached hereto, and with respect to Trademarks (as defined in the Security Agreement) and the goodwill of Debtor's business connected therewith, including, but not limited to any of those described more fully in Schedule C attached hereto and any and all trademark applications including, but not limited to any of those described more fully in Schedule D attached hereto. The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
