behoof and the use and behoof of its successors, legal representatives and assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted, as fully and entirely as the same would have been held and enjoyed by the assignor, had this sale and assignment not been made, including the right to seek and collect past, present and future damages for infringement of the Vehicle Barrier IP.

AND for the same consideration, said assignor hereby covenants and agrees to and with said assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, said assignor is the sole and lawful owner of the entire right, title and interest in and to said Vehicle Barrier IP, and that the same are unencumbered and that said assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth.

AND for the same consideration, said assignor hereby covenants and agrees to and with said assignee, its successors, legal representatives and assigns, that said assignor will, whenever counsel of said assignee or the counsel of its successors, legal representatives and assigns, shall advise that any proceeding in connection with said Vehicle Barrier IP, or any proceeding in connection with Letters Patent for said Vehicle Barrier IP in any country, including interference proceedings, is lawful and desirable, that any division, continuation or continuation-in-part of any application for Letters Patent, or reissue or extension of any Letters Patent, to be obtained thereon, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent for said Vehicle Barrier IP, without charge to said assignor, its successors, legal representatives and assigns, but at the cost and expense of said assignee, its successors, legal representatives and assigns.
