WHEREAS, I now own the partial right, title and interest in and to the Invention which shall be referred to as the "Inventive Subject-Matter" in this Assignment; and

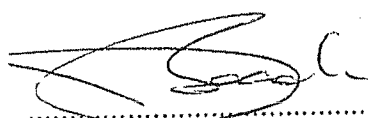
