**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby irrevocably and forever releases and terminates its security interest in and to the Released Intellectual Property arising under the Pledge Supplement including, without limitation, the intellectual property described in Exhibits

A-I, A-II and A-III hereto. Further, Secured Party understands and agrees that this Release may be recorded by or for Grantor with the Trademark Assignment Branch and the Patent Assignment Branch of the United States Patent and Trademark Office and any other similar offices or agencies throughout the world. Secured Party also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Grantor may reasonably require to effect the intent and purpose of this Release.
