## ASSIGNMENT OF PATENT RIGHTS AND AGREEMENT

[referred to as "Fraunhofer"] and CONSORZIO NAZIONALE INTERUNIVERSITARIO PER LE TELECOMUNICAZIONI [referred to as "CNIT"];

WHEREAS Datalogic IP Tech S.r.l. with business residence in via San Vitalino 13, 40012 Calderara di Reno (Bologna), ITALY [referred to as the "Assignee"] desires to obtain the Assignor's entire right, title and interest in and to said Patents and in and to any letters patent that may be granted in respect of said Patents;

AND WHEREAS the Assignor desires to assign to the Assignee its entire right, title and interest in and to said Patents and in and to any letters patent that may be granted in respect of said Patents;


NOW THEREFORE IT IS AGREED that for and in consideration of the sum of one U.S. Dollar (\$1) paid by the Assignee to the Assignor, and other good and valuable consideration, the receipt whereof the Assignor hereby acknowledges:

1. The Assignor hereby assigns and transfers by these presents unto the Assignee and their successors their entire right, title and interest in and to all inventions and improvements disclosed in the Patents, in and to said Patents, in and to all national and regional phases, divisions and continuations thereof, in and to any Letters patent granted in respect of the Patents and all reexaminations and reissues thereof, and all and singular the liberties, powers, privileges, advantages and immunities whatsoever appertaining or belonging thereunto, including the right to claim priority therefrom and the right to recover damages and claim all other relief in respect of any past, present and future infringement and violation, including full power to the Assignee to cause their name to be substituted for the Assignor name as applicant for letters patent in respect of the said Patents and including full power to the Assignee to proceed with the said Patents for letters patent in their name;

2. The Assignor hereby assigns and otherwise transfers to the Assignee all rights, title and interest held by Assignor in and to the Patent Joint Ownership Agreement effective December 15, 2015 between the Assignor, Fraunhofer and CNIT [referred to as the "Agreement"]. Assignor warrants and represents that said Agreement is in full force and effect and is fully assignable. Assignor further warrants that it has the full right and authority to transfer said Agreement and that the rights herein transferred are free of lien, encumbrance or adverse claim. Said Agreement has not been modified and remains on the terms contained therein. Assignee hereby accepts all rights and assumes and agrees to perform all obligations of Assignor under the Agreement and agrees to indemnify and hold Assignor harmless from any claim or demand resulting from non-performance by Assignee. This Assignment shall become effective as of the date last executed and shall be binding upon and inure to the benefit of the parties, their successors and assigns.


