ASSIGNMENT AGREEMENT

At the reasonable request of Assignee, at any time or from time to time after the date of this Assignment Agreement, Assignor shall take all actions necessary to put Assignee in actual possession and operating control of the Patent and any prototype, and shall execute and deliver such further instruments of sale, conveyance, transfer and assignment and take such other action as Assignee may reasonably request in order to sell, convey, transfer and assign to Assignee the Patent and any prototype.

Assignors constitutes and appoints Assignee as their lawful attorney-in-fact, with full power of substitution, in Assignors' names to: (a) demand and receive any and all of the Patent and prototypes; (b) give receipts and releases for and in respect of the Patent; and (c) give any notices and do all acts and things in relation to the Patent that the Assignee deems desirable, including

executing and delivering any legal or other document or pursuing any proceeding to assert or enforce any claim, right or title in or to the Patent; (d) change record ownership of the Patent with the USPTO or with any other governmental, quasi-governmental, private, public or individual entities that may have a record of the Patent, including, but not limited to leasing companies, taxing authorities, etc.

Assignors understand and ^{agree} acquiesce that the execution of this document transfers sole ownership and control of the Patent and prototype to Assignee, and that Assignors no longer maintain nor retain any right of ownership or control over the Patent and any prototypes. Furthermore, Assignors may not encumber, lien, use as collateral to third parties, or otherwise place any claim against the patent or any prototypes.

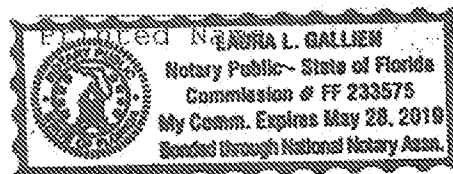

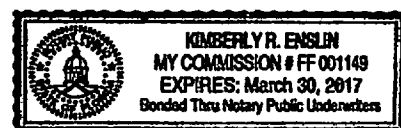
