Assignor also sells and assigns to Assignees, their successors, assigns and legal representatives, the full and exclusive right, title, and interest to the Invention disclosed in said Application throughout the world in a percentage of fifty percent (50%) to each, including the right to file applications and obtain patents, utility models, industrial models, and designs for the Invention in the Assignees' own names throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of the Invention and all rights to register the Invention in appropriate registries, all foreign rights arising from pre-grant publication of the Application; and Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignees, their successors, assigns and legal representatives.

Assignor further agrees to communicate to Assignees, their successors, assigns and/or legal representatives, any known facts respecting any improvements, and, at the expense of Assignees, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in Assignees and to aid Assignees, their successors, assigns and legal representatives to obtain and enforce proper protection for the Invention in all countries.
