This assignment and agreement shall be binding upon assigns, successors, heirs and legal representatives of Assignor and Assignee.

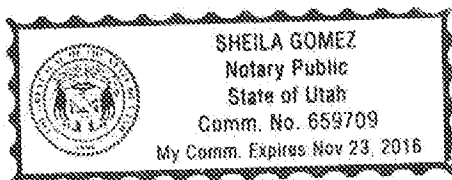


