And by these presents does hereby sell, assign, transfer and set over its entire right, title and interest in and to said Letters Patent and said inventions, and all rights to take action against, and to collect and keep all judgments for, infringement of said Letters Patent for all past, present and future infringement of said Letter Patent.

Assignor agrees that it or its heirs, successors, assigned, or other legal representatives will at any time at the request and at the expense of the Assignee or its heirs, successors, assigns, or other legal representatives, without undue delay, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect the title to the invention and the Letters Patent.

Assignor further assigns to Assignee or its heirs, successors, assigns, or other legal representatives the whole right, title, and interest in and to the invention throughout all countries foreign to the United States, including the right to (1) file any divisional, continuation, and continuation-in-part applications claiming priority to the foreign patent application where such procedure is proper and (2) seek reissues or extensions of any foreign patent. Assignor ratifies any acts of Assignee in applying for a foreign patent in Assignee's own name in any foreign country where such procedure


