

In-Ear Utility Device

[0001] This is an application for a new, original, and ornamental design for an IN-EAR UTILITY DEVICE, of which the following is a specification, reference being had to the accompanying drawings, forming a part thereof. The in-ear utility device can, for example, be a wireless in-ear device for use in providing a variety of services to users, such as music playing, sound amplification, and sports monitoring devices. The inventors anticipate that the invention can be any part, portion, element, or combination of elements of the depicted design.

DESCRIPTION OF THE DRAWINGS

[0002] Figure 1 is a front perspective view of an in-ear utility device showing our new design;

[0003] Figure 2 is a front side view thereof;

[0004] Figure 3 is a right side perspective view thereof;

[0005] Figure 4 is a left side perspective view thereof

[0007] Figure 6 is a right side view thereof;

[0008] Figure 7 is a bottom view perspective thereof; and

[0009] Figure 8 is a bottom perspective view.

1. The ornamental design for an IN-EAR UTILITY DEVICE, as shown and described.

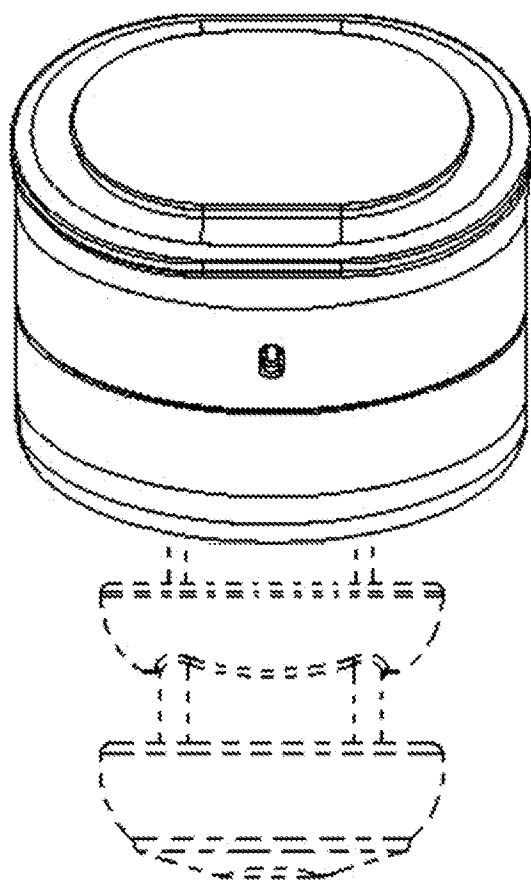

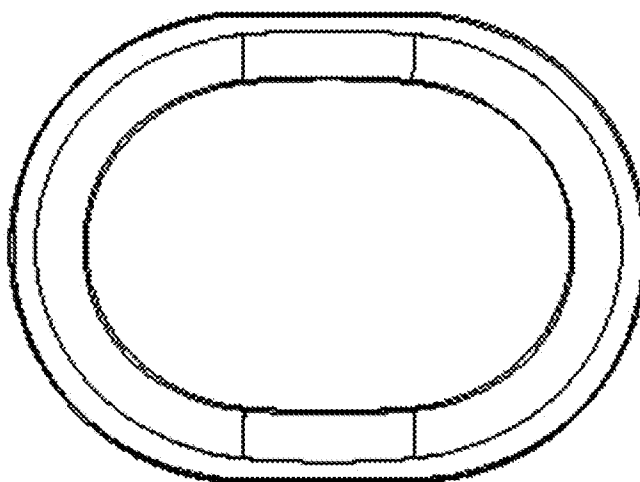

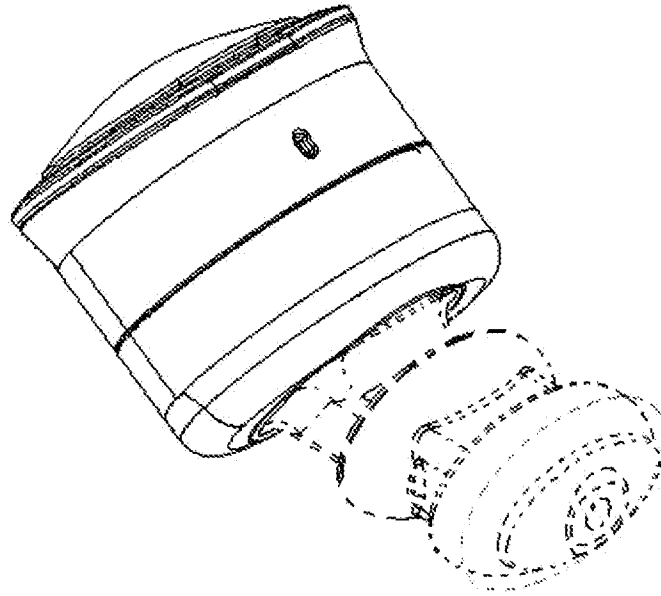

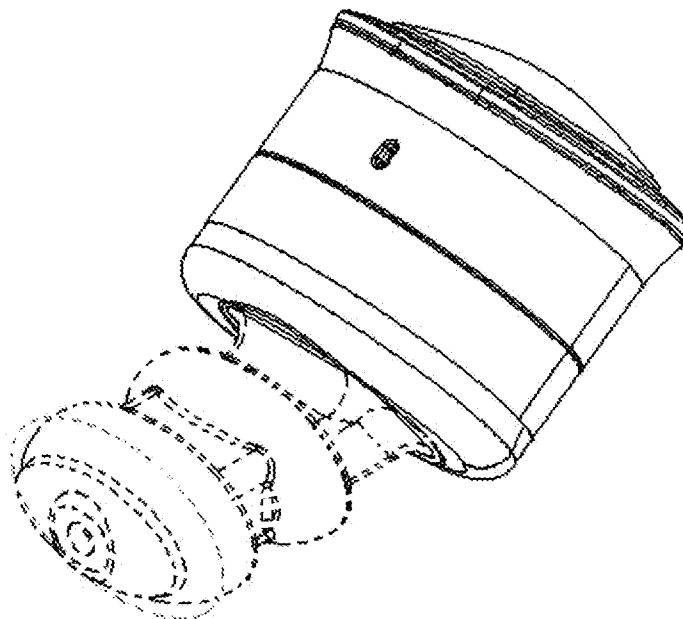

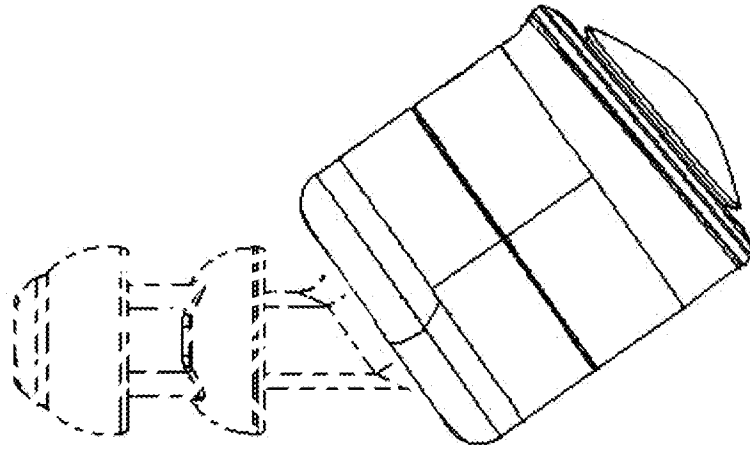

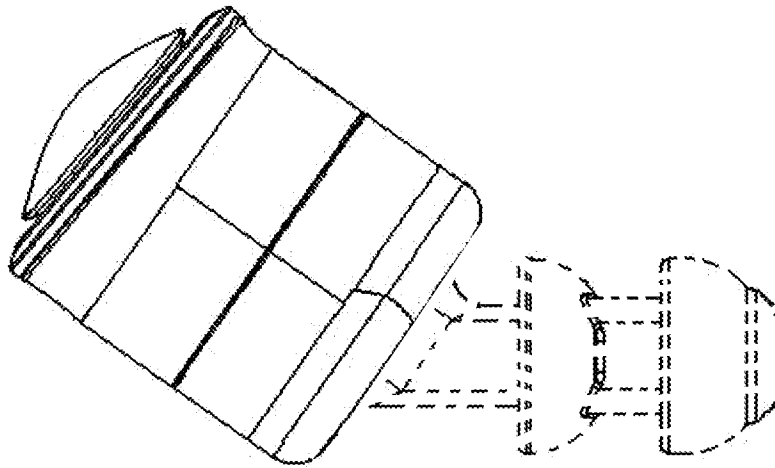

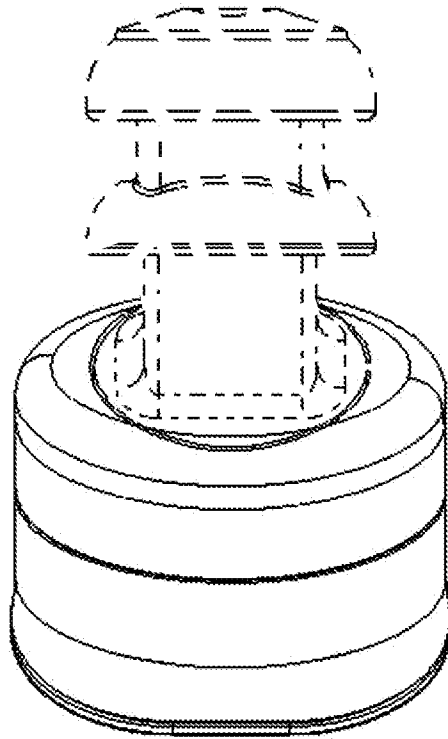

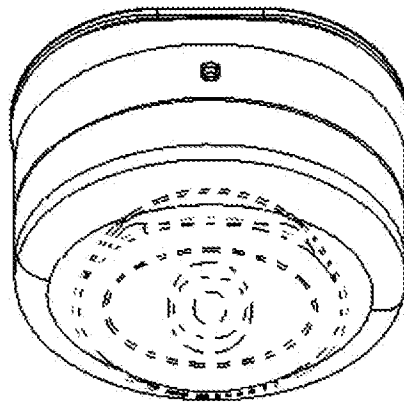
