

reissue application or applications for patent based on the present application, as well as for any other U.S. or foreign application for patent which relates to the said invention.

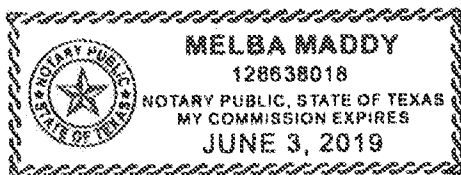


