AND said ASSIGNOR hereby agrees to execute any further agreements and to take any further actions necessary to aid ASSIGNOR in perfecting its interest in the PATENT and any and all renewals, reissues and prolongations thereof and in enforcing any and all protections or privileges deriving from the Letters Patent.
