ASSIGNORS also hereby convey and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries, and all rights to enforce said rights against others and recover damages for infringement thereof at any time; and ASSIGNORS

further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

ASSIGNORS hereby further agree to communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to ASSIGNORS respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries. ASSIGNORS further represent that ASSIGNORS own the rights being conveyed by this Assignment and have not previously encumbered or assigned to any person or entity other than ASSIGNEE any right that is being assigned to ASSIGNEE herein.
