2. Authorize and request the United States Patent and Trademark Office or any other U.S. or non-U.S. agency to issue to the Assignee any and all patent(s), or other

rights or documents, resulting from the intellectual property, patent application(s) and patents described in paragraph 1 of this Assignment.
