NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, I have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto said Connecticut Container Corp., its successors, legal representatives, and assigns the entire right, title, and interest in, to and under said improvements, and said application and all divisions, renewals, and continuations thereof, and all Letters Patent of the United States which may be granted thereon or claim priority therefrom and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for said improvements or claim priority therefrom in any country or countries foreign to the United States and all extensions, renewals, and reissues thereof; and I hereby authorize and request the Commissioner of Patents of the United States and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to said Connecticut Container Corp., its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY further assign and transfer to Connecticut Container Corp. all priority rights derived from such application therefore by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International convention and do hereby assign and transfer to Connecticut Container Corp. the sole right to file further applications for patents under the patent laws of any country of the world based on any improvements disclosed in said application as fully and entirely as the same would have been held by me had this assignment not been made.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.


AND I HEREBY further covenant and agree that I will communicate to said Connecticut Container Corp., its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid said Connecticut Container Corp., its successors, legal representatives and assigns to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY declare, as the inventor named above, that: (1) the above-identified application was made or authorized to be made by me; (2) I believe that I am the original inventor or an original joint inventor of a claimed invention in the application; (3) I hereby acknowledge that any willful false statement made in this declaration is punishable under 18 U.S.C. 1001 by fine or imprisonment of not more than (5) years, or both.
