This Patent and Inventions Assignment shall have been effective as of May 7, 2015.

Assignor hereby acknowledges and agrees that Assignee and/or any of its successors, assigns and/or legal representatives may record the assignment of rights in all Inventions, including but not limited to in all patent applications and registrations identified on Schedule A, and may apply for, and if issued receive, patents for the Inventions for filing in Assignee's own name; and that, when requested by Assignee, or any of its successors, assigns or legal representatives, to carry out the intent or purpose of this Patent and Inventions Assignment, Assignor shall promptly: (i) execute all divisional, continuing, substitute, renewal, and reissue patents and applications, and all other patent applications, relating to any of the Inventions in or for the United States and/or any and all foreign countries, and all rightful oaths, declarations, assignments, powers of attorney and other papers relating to any of the foregoing; (ii) communicate to Assignee, and its successors, assigns and legal representatives, all facts known to Assignor relating to any of the Inventions and the history thereof; (iii) testify as to all pertinent facts and documents relating to the Inventions as may be known or accessible to Assignor in any interference, litigation or proceeding related thereto, at Assignee's cost and expense; and (iv) generally do everything reasonably possible which Assignee, or any of its




