

FURTHER, for the avoidance of doubt, Assignor confirms that the assignment of the full and exclusive right to the invention in the United States and its territorial possessions and in all foreign countries, as of the Effective Date and as set forth in the Assignment, includes the assignment of right to claim the benefit of priority in all countries in accordance with Paris Convention Article 4A(1) or as otherwise required by any national or international authority, from: (1) the Application; and (2) any applications to which the Application claims priority.
