Assignor Hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States,


whose duty it is to issue patents to issue the same to Company, its successors, legal representatives and assigns, in accordance with the terms of this instrument; and


