- c. otherwise preserve the validity of the Patents described in Schedule 1 against any and all infringers, and perform such other acts that are necessary to give full force and effect to this Patent Assignment.

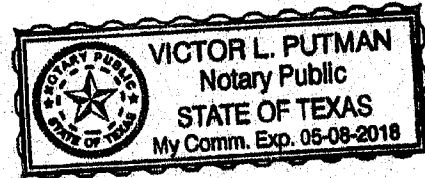

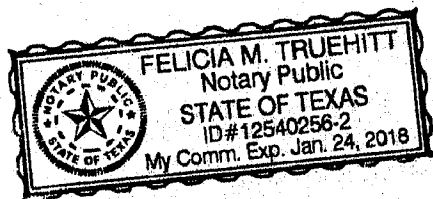
