ASSIGNMENT OF PATENT RIGHTS

1. ASSIGNMENT

- (d) the right to extend to or register in or in respect of any country or territory in the world each and any of the Patents, and each and any of the applications filed as aforesaid, and to extend to or register in, or in respect of, any country or territory in the world any patent or like protection granted on any of such applications;
- (e) the absolute entitlement to any patents granted pursuant to any of the Patents or applications filed as aforesaid, for their full period, including any re-issues, re-examinations, renewals, extensions and Supplementary Protection Certificates; and
- (f) the right to bring, make, oppose, defend, or appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Patents or any patents granted on any of the applications filed as aforesaid, whether occurring before on or after the date of this assignment.

2. ISSUE OF PATENTS

The Inventor requests the relevant authorities in all countries, regions and territories of the world to issue any patents granted for any inventions

disclosed in the Patents or pursuant to any patent application mentioned in clause 1 of this agreement in the sole name of the Assignee (or its successors or assigns) in accordance with this agreement.
