that certain written Promissory Note (hereinafter referred to as the "Promissory Note") in the 1 2 principal sum of five hundred thousand dollars (\$500,000.00), together with interest at the rate of 3 20% per annum. Plaintiff alleges that pursuant to the Promissory Note, all unpaid principal and 4 interest was due and payable to Plaintiff no later than the maturity date of June 15, 2013, but that 5 Wagic breached the Promissory Note by failing to pay all sums due and owing Plaintiff on the 6 maturity date of June 15, 2013. Through the Complaint, Plaintiff seeks damages in the amount of 7 the outstanding principal and interest due pursuant to the Promissory Note in the amount of 8 \$696,436.49 as of December 1, 2014, plus interest as it continues to accrue thereafter at the rate 9 of 20% per annum, plus all costs of collection including but not limited to attorneys' fees and 10 costs pursuant to the Promissory Note.

11 Plaintiff duly served Wagic with the Complaint for Breach of Contract herein on 12 December 9, 2014. After Wagic failed to answer or otherwise respond thereto, the default of 13 Wagic was entered on January 1, 2015. As a result of the default, Wagic is deemed to have admitted all allegations in the Complaint. (See Vasey v. California Dance Co., Inc. (1977) 70 14 15 Cal.App.3d 742, 749; Molen v. Friedman (1998) 64 Cal.App.4th 1149, 1156 [By defaulting, a 16 defendant is deemed to admit the material allegations of the complaint for purposes of the 17 action].).

18 The allegations of Plaintiff's Complaint having been proven to the Court's satisfaction, 19 and upon consideration of all papers, evidence, and argument submitted by Plaintiff at the 20 Hearing, and good cause appearing therefore, IT IS HEREBY ORDERED, ADJUDGED and 21 **DECREED** that:

22 Judgment is entered in favor of Plaintiff and against Wagic in the total amount of 23 \$736,595.47. The foregoing sum includes: (1) principal due and owing from Wagic pursuant to 24 the Promissory Note in the amount of \$500,000.00; (2) interest at the rate 20% per annum, 25 pursuant to the Promissory Note, for the period from December 14, 2012 through the date of the 26 Hearing ($500,000 \times 20\% \div 365 \times 801 \text{ days}$), which totals 219,449.97; (3) attorneys' fees of 27 \$14,700.50 pursuant to the Promissory Note; and (4) costs of \$2,445.00 pursuant to the Promissory Note as of the date of the Hearing, which have been incurred by Plaintiff in 28 HOPKINS & CARLEY - 2 -697\1196812.2 ATTORNEYS AT LAW DECLARATION OF RAYMOND FIGONE IN SUPPORT OF APPLICATION FOR RIGHT TO ATTACH ORDER AND WRIT OF ATTACHMENT AS TO DEFENDANT WAGIC, INC.
