AND ASSIGNOR HEREBY authorizes and requests the Commissioner for Patents or any other proper officer or agency of any country whose duty it is to issue patents on applications as described above, to issue all said Letters Patent to Dixie, as assignee;

AND ASSIGNOR HEREBY warrants and covenants that I have full right to convey the entire interest herein assigned and that I have not executed and will not execute any instrument or assignment in conflict with this Assignment;

AND ASSIGNOR HEREBY agrees to communicate to Dixie or its representatives any facts known to me respecting said invention and/or Application, to execute all divisional, continuation, continuation-in-part, reexamination, reissue and foreign applications, sign all lawful documents and make all rightful oaths and declarations relating to said invention and/or Application, and to testify in any judicial or administrative proceeding and generally do everything possible to aid Dixie to secure

full and complete protection for the invention and/or Application or that may be necessary to vest in Dixie the complete title to the invention and/or Application hereby conveyed and to enable it to record said title and enforce said Letters Patent in the United States or any foreign country when requested so to do by Dixie.
