ASSIGNMENT

NOW, THEREFORE, in consideration of One (1) Dollar and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned does hereby sell, assign, and transfer to Assignee and the legal representatives, successors, and assigns of the Assignee, the entire right, title and interest in and to: (1) the invention described in the Patent, including all know-how relating thereto; and (2) the Patent, including any and all subsequent related applications and issued patents, including continuation applications, divisional applications, continuation-in-part applications, international applications, foreign/national phase applications, and any reissue or reissues of the Patent, the same to be held and enjoyed by the Assignee as fully and entirely as the same would have been held and enjoyed by the undersigned had this assignment and sale not been made, and together with all claims for damages by reason of past infringement of the Patent with the right to sue for and collect the same for the Assignee's own use.

The undersigned also covenants and agrees with the Assignee that the undersigned has the full right to convey the interest sold and assigned and has not executed and will not execute any writing or do any act whatsoever in conflict with the rights and interest assigned; and that the undersigned will at any time upon request, without further or additional consideration, but at the expense of the Assignee: execute such additional assignments and other documents and do such additional acts as the Assignee may deem necessary or desirable to perfect or confirm this assignment and the Assignee's enjoyment of the rights acquired; and aid in enforcing any rights accruing as a result of the Patent by giving testimony in any proceedings or transactions involving the

Patent and by cooperating in the execution of documents, statements, affidavits, etc. that may be required in any such proceeding or transaction.

It is understood that the foregoing covenants and agreements shall bind the legal representatives of the undersigned and inure to the benefit of the legal representatives, successors and assigns of the Assignee.
