AND FOR THE SAME CONSIDERATION, the Assignor agrees that it will, without further consideration, do all such things and execute all such documents as may reasonably be necessary or desirable to obtain and maintain patents for the invention and for any improvements thereto in Canada and throughout the world and to vest title to the invention in the Assignee, its successors, assigns and legal representatives or nominees.
