for which a design patent application was filed with the United States Patent and Trademark Office on **January 28, 2016** and assigned patent application serial number **29/553,067**.

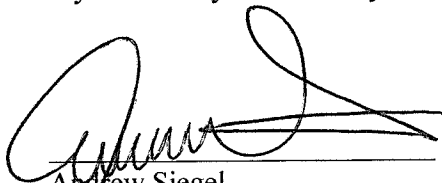

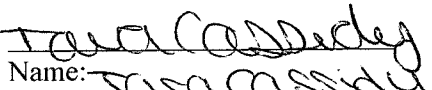
