

**FIRST:** The name of the surviving corporation is Vonage America Inc., a Delaware corporation, and the names of the limited liability companies being merged into the surviving corporation are Vonage Marketing LLC; Vonage Network LLC; and Intellectual Property Asset Management, LLC, each a Delaware limited liability company.
