made; and specifically including all rights of priority created by the Patent under any treaty, convention or law relating thereto.

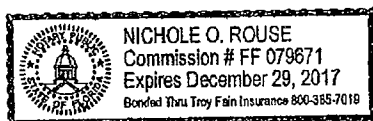
