AND, I hereby authorize and request the Commissioner of Patents of the United States, its territorial possessions, and any and all foreign countries to issue any and all Letters Patent on said inventions, or resulting from said applications, and from any and all divisions and continuations, extensions, reissues or reexaminations thereof to the said ASSIGNEE, of the entire right, title and interest, and hereby covenants that I have full right to convey the entire interest therein assigned, and that I have not executed and will not execute any agreement in conflict therewith.

AND, I further hereby covenant and agree that I will, at any time, upon request, at the expense of said ASSIGNEE, execute and deliver any and all papers that may be necessary or desirable to perfect the title to said inventions, and to said Letters Patent as may be granted therefor, in said ASSIGNEE, its successors, assigns, or other legal representatives, and that if said ASSIGNEE, its successors, assigns, or other legal representatives shall desire to file any divisional or continuation application, or to secure an extension, a reissue or certificate of reexamination of such Letters Patent, or to file a disclaimer relating thereto, will, upon request, sign all papers, make all rightful oaths, and do all acts requisite for the filing of such divisional or continuing application, or such application for extension, reissue or request for reexamination and procuring thereof, and for the filing of such disclaimers, without further compensation, but at the expense of said ASSIGNEE, its successors or other legal representatives.

AND, I do further covenant and agree, that I will, at any time, upon request, communicate to said ASSIGNEE, its successors, assigns, or other legal representatives, at its expense, such facts relating to said inventions and Letters Patent or the history thereof, as may be known to me, and testify as to the same in any interference or other litigation, when requested to do so.
