## PATENT ASSIGNMENT

### AGREEMENTS

  - (a) all inventions, improvements, and modifications disclosed and/or claimed in the Assigned Patents;
  - (b) all rights to claim priority in any Assigned Patents, including any pending or subsequent U.S. and foreign patent applications, and including the right to claim, for any of said applications, the full benefits and priority rights under the International Convention and any other international agreement to which the United States adheres, where the rights, title, and interest are to be held and enjoyed by the Assignee, its successors and assigns, to the full end of the term or terms for which any and all of the Assigned Patents are granted, as fully and entirely as would have been held and enjoyed by Assignor had this Patent Assignment not been made;
  - (c) any and all patents issuing from pending patent applications listed in Appendix A, as well as any and all patents issuing from continuations, continuations-in-part, reissues, re-examinations, or divisions of the Assigned Patents regardless of whether such patents mature from convention or non-convention applications or any other substitutions, renewals, extensions, additions, utility models or other United States or foreign patents;
  - (d) all renewals thereof; and
  - (e) all rights of action, powers, and benefits accrued thereto, including the rights conferred to the holders of the Assigned Patents by the US Patent and Trademark Office or any corresponding foreign authority, including but not limited to the right of enforcement of the Assigned Patents for any and all claims of past, present, and future infringement and any relief resulting from such claims, including both equitable and monetary relief, in forms including but not limited to injunctions, damages, and royalties.

2. Assignment of Assigned Patents. Subject to the terms, conditions, and limitations set forth herein, Assignor hereby sells, assigns, transfers, conveys, and grants to the Assignee, its successors and assigns all of Assignor's rights and title to and interest in the Assigned Patents, free and clear of all liens and encumbrances, including the right to claim priority in and to the same.

3. Further Assurances and Documentation. Upon request by Assignee, Assignor will take, or cause to be taken, all actions and do, or cause to be done, all things necessary, proper or appropriate to confirm Assignee's ownership of the Assigned Patents and to otherwise effectuate the transactions contemplated by this Patent Assignment, including but not limited to executing any additional documents as may be necessary in order to record this Patent Assignment in a foreign jurisdiction pursuant to the applicable rules of such jurisdiction.

4. Governing Law. This Patent Assignment shall be governed by the laws of the state of Wisconsin and the patent laws of the United States without giving effect to any rule or provision thereof which would cause the application of the law of any other state.
