WHEREAS, I,

### DEVICE FOR HOLDING AND DEPLOYING APPARATUS FOR USE IN THE SPACE

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, I the said inventor have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the said **AEREA S.p.A.**, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said improvements, and the said application - including the right to claim priority to said application - all divisions, renewals and continuations thereof, and all Letters Patent which may be granted thereon and all reissues and extensions thereof, and I hereby authorize and request the Commissioner of Patents of the United States to issue all Letters Patent for said improvements to the said **AEREA S.p.A.**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to **AEREA S.p.A.**, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible

to aid AEREA S.p.A., its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in the United States;

AND I HEREBY grant Heslin Rothenberg Farley & Mesiti, P.C. the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document;

AND I HEREBY, as the above named inventor, declare that the above-identified application was made or authorized to be made by me;

AND I HEREBY, as the above named inventor, declare that I believe that I am the original inventor of a claimed invention in the above-identified application;

AND I HEREBY state that I have reviewed and understand the contents of the above-identified specification, including the claims;

AND I HEREBY acknowledge the duty to disclose to the United States Patent and Trademark Office all information known to us to be material to patentability as defined in Title 37, Code of Federal Regulations, Section 1.56;

AND I HEREBY declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that any willful false statements and the like so made in this declaration are punishable by fine or imprisonment of not more than five (5) years, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.
