ASSIGNMENT

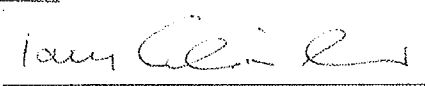

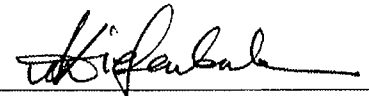

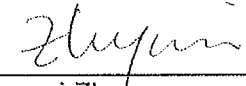
