ASSIGNMENT OF SECURITY INTEREST

(A) All of the Grantor's right, title and interest in and to (i) the **Initial Patent Application**; (ii) the United States Letters Patent and the inventions described and claimed therein and set forth hereto and any other future patents of Grantor, including those based on continuation, continuation-in-part, divisional and substitute applications, patents resulting from a reissue or reexamination proceeding, and any foreign equivalents and improvements thereof (hereinafter referred to collectively as the "**Patents**"); (iii) the provisional and non-provisional applications for Letters Patent and the inventions described and claimed therein set forth hereto and any United States Letters Patent which may be issued upon any of said applications and any future patent applications of Grantor (hereinafter, together with the Initial Patent Application, referred to collectively as the "**Applications**"); (iv) any reissue, extension, division or continuation of the Initial Patent Application, the Patents or the Applications (such reissues, extensions, divisions and continuations being herein referred to collectively as the "**Reissued Patents**"); (v) all future royalties or other fees paid or payment or payments made or to be made to the Grantor in respect of the Initial Patent Application, Patents, Applications and Reissued Patents (referred to collectively as the "**Royalties**"); and (vi) proceeds of any and all of the foregoing (namely, the Initial Patent Application, the Patents, Applications, Reissued Patents and Royalties and proceeds being herein referred to collectively as the "**Patent Rights**"); and

(B) All rights, interests, claims and demands that the Grantor has or may have in existing and future profits and damages for past and future infringements of the Patent Rights.
