In consideration of the sum of one dollar now paid by the Assignee to the Assignor, as well as other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, the Assignor as beneficial owner hereby assigns the entire right, title and interest in said US Application, including all right of priority therefrom in any and all Applications for Patent (hereinafter referred to as "the Corresponding Applications") and any and all Patents granted pursuant to the Corresponding Applications which derive the right of priority, directly or indirectly, from the above-captioned US Application (hereinafter referred to as "the Corresponding Patents), any and all divisions thereof and all the rights, powers, liberties and immunities arising or accrued therefrom including the right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of the specifications accompanying the Corresponding Applications, to the Assignee free from all licence charges or other encumbrances to the intent that the filing of the Corresponding Applications and a grant of the Corresponding Patents thereon shall be in the name of and shall vest in the Assignee to hold unto the Assignee absolutely.
2. The Assignee hereby accepts such assignment.
