AND I HEREBY further covenant and agree that I will communicate to Assignee any facts known to me respecting said improvements, and testify in any legal proceeding,

sign all lawful papers, execute all non-provisional, divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY declare that I believe I am the original inventor or an original joint inventor of a claimed invention in the application.

AND I HEREBY declare that the above-identified application(s) was/were made or authorized to be made by me.

AND I HEREBY acknowledge that any willful false statement made in this declaration is punishable under 18 U.S.C. 1001 by fine or imprisonment of not more than five (5) years, or both.
