ASSIGNMENT

- (IV) FURTHER, be it known that the Assignor has assigned, and transferred, and hereby does assign, and transfer unto the Assignee, its successors and assigns: (1) the entire foreign rights to the invention disclosed in the Application, in all countries of the world, including the right to file applications and obtain patents under the terms of the Paris Convention for the Protection of Industrial Property, and of the European Patent Convention, and (2) the right to claim the benefit of priority from the Application in all foreign countries in accordance with Paris Convention Article 4A(1) or as otherwise required by any national or international authority.
- (V) FURTHER, Assignor does hereby covenant and agree that: (1) they have full right to convey the entire right, title, and interest assigned herein; (2) they have not executed, and will not execute, any agreement(s) in conflict herewith; and (3) this assignment is binding on Assignor and Assignor's heirs, successors, assigns, and legal representatives.
- (VI) FURTHER, Assignor does hereby covenant and agree that they will assist the Assignee in: (1) the prosecution of the application herein identified; (2) the making and/or prosecution of any other patent applications that the Assignee may elect to make covering the invention herein identified, including any applications for reissue, reexamination, or foreign patent rights, (3) any proceeding relating to the invention, including all applications and patents

arising therefrom, in any patent office, including but not limited to interferences and derivation proceedings; and (4) all post-grant proceedings, both ex parte and inter partes, involving any patent arising from the application and all divisions, reissues, substitutions, continuations, continuations-in-part, and extensions thereof.

(VII) FURTHER, Assignor does hereby covenant and agree to: (1) promptly execute and deliver to Assignee any and all patent applications, assignments, affidavits, and any other papers necessary to perfect patent rights assigned herewith; (2) promptly execute and deliver to Assignee any and all additional papers and to make all lawful oaths which may be requested by Assignee to fully carry out the terms of this assignment; (3) communicate to Assignee, or to its successors, assigns, and legal representatives, any facts known respecting said invention; (4) at the expense of Assignee, testify in any legal proceedings related to the invention; and (5) generally perform all affirmative acts necessary to aid Assignee, its successors, assigns, and nominees to obtain, maintain, and enforce patent protection for said invention in all countries.

(VIII) FURTHER, in the event that: (1) Assignor is unable to fulfill any of the obligations set forth hereinabove through incapacity or death; or (2) Assignee is unable, after reasonable efforts, to obtain Assignor's fulfillment of any of said obligations, Assignor does hereby agree that this Assignment shall be a valid Power of Attorney authorizing Assignee to take necessary actions on behalf of Assignor, or their estate in the event of Assignor's death, for fulfillment of said obligations.

(IX) FURTHER, Assignor authorizes and requests that: (1) a representative duly appointed by the Assignee, insert the filing date and application number in the above indicated spaces when known; and (2) all national and international authorities issue to the Assignee all patents relating to the invention in accordance with the terms of this Assignment.
