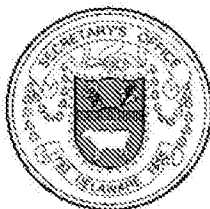

THIRD: The name of the surviving corporation is Acuity Brands Lighting, Inc.


