and does hereby sell, assign and transfer unto Assignee, its successors and assigns, all of Assignor's right, title and interest in and throughout the United States of America (including its territories and dependencies) said United States applications, any other United States applications (including provisional, non-provisional, divisional, continuing, or reissue application) based in whole or in part on said United States applications or in whole or in part on said inventions, and any and all United States patents (including extensions thereof) which have been or may be granted on any of the aforesaid applications or on said inventions or any part thereof; including, specifically, without limiting the generality of the foregoing, the United States application listed below.

4. **TO BE HELD AND ENJOYED BY** Assignee, its successors and assigns, to the full ends of the respective terms full for which said patents have been or may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale and assignment not been made.

5. **AND** Assignor hereby authorized and requests the Director of the United States Patent and Trademark Office of the United States of America to issue any and all United States patents which may be granted upon said United States patent applications to Assignee, its successors and assigns.




