Whereas, **Douglas A. Standley**, an individual, residing at 2801 Pennsylvania Ave., #104, Boulder, Colorado 80303, **Matthew R. Assignors also sell and assign to Assignee, its successors, assigns and legal representatives the full and exclusive right, title, and interest to the Invention throughout the world, including the right to file applications and obtain patents, utility models, industrial models, and designs for the Invention in the Assignee's own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of the Invention and all rights to register the Invention in appropriate registries, all foreign rights arising from pre-grant publication of the Provisional and/or Utility Application; and Assignors further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee, its successors, assigns and legal representatives.

Assignors further agree to communicate to Assignee, its successors, assigns and/or legal representatives, any known facts respecting any improvements, and, at the expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in Assignee and to aid Assignee, its successors, assigns and legal

representatives to obtain and enforce proper protection for the Invention in all countries.
