## **Patent Assignment**

Whereas, **Societal Innovation North America, Inc.**, a Delaware corporation, located at 295 Interlocken Blvd. Suite 500, Broomfield, Colorado 80021 (“Assignor”), has acquired all right, title and interest in and to the invention entitled SYSTEM AND METHOD FOR RECEIVING AND PROCESSING SIGNALS FROM ONE OR MORE SOURCES IN REAL TIME USING A CONFIGURABLE PLATFORM INSTANCE (the “Invention”) from inventors Douglas A. Now, therefore, for other good and valuable consideration, Assignor, by these presents does hereby sell, assign, and transfer unto Assignee, its successors, assigns, and legal representatives the full and exclusive right to the Provisional Application and the Utility Application in the United States and the entire right, title, and interest in and to any and all Patents which may be granted therefor and/or therefrom in the United States, to all divisions, reissues, substitutions, continuations, continuations-in-part, and extensions of said Invention. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all patents for any the currently pending applications, or patents resulting therefrom, insofar as Assignor’s interests are concerned, to Assignee, of the entire right, title, and interest in and to the same, for its sole use and benefit; and for the use and benefit of its legal representatives, to the full end of the term for which said Patent(s) may be granted, as fully and entirely as the same would have been held by the Assignor had this assignment not been made.

Assignor also sells and assigns to Assignee, its successors, assigns and legal representatives the full and exclusive right, title, and interest to the Invention throughout the world, including the right to file applications and obtain patents, utility models, industrial models, and designs for the Invention in the Assignee’s own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of the Invention and all rights to register the Invention in appropriate registries, all foreign rights arising from pre-grant publication of the Provisional and/or Utility Application; and Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee, its successors, assigns and legal representatives.

Assignor further agrees to communicate to Assignee, its successors, assigns and/or legal representatives, any known facts respecting any improvements, and, at the expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in Assignee and to aid Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for the Invention in all countries.
